# ALLEY THEATRE Vision For The Future Campaign

After Hurricane Harvey in 2017, the Board of Directors approved a capital/endowment campaign entitled the Vision for the Future Campaign. The campaign has four objectives: to double the size of the Alley's Endowment, pay off all the losses not covered by insurance from Hurricane Harvey, provide a 10-year investment into the Artistic Investment Fund to ensure the highest artistic quality of the productions, and establish financial reserves.

In 2022, Alley Theatre received the largest contribution in its history in the form of a \$25 million challenge grant from the Meredith J. Long family. Serving on the Alley Theatre Board for 31 years beginning in 1989, Meredith held the role of Chairman and later Chairman Emeritus. In order to realize the challenge grant, matching gifts must be raised by June 30, 2025.

When this gift is matched, it will successfully conclude the Alley's \$80 Million Vision for the Future Campaign. We are grateful to all who have contributed to this campaign, which is vital to the long-term success of Alley Theatre.
