Launched in 2017 after the devastation of Hurricane Harvey, the Vision for the Future Capital Campaign was bolstered in 2022 by a transformational \$25 million challenge grant in honor of Meredith J. Long, Chairman Emeritus of the Alley Theatre Board. The Theatre achieved the \$25 million match on June 30, 2026, accomplishing the campaign's four objectives:



- 1 | Double the Alley's Endowment
- 2 | Eliminate all uninsured losses from Hurricane Harvey
- 3 | Create emergency financial reserves, enhancing the Theatre's ability to withstand future challenges; and
- 4 | Establish a 10-year infusion into the Artistic Investment Fund, ensuring high-quality productions and artistic excellence.
